#### **How Long this Coverage Lasts**

This warranty shall remain effective for one (1) year from the date of original purchase.

#### Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

## What Solo Technology Will Do

Solo Technology will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

- 1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. Solo Technology will also pay the shipping costs necessary to return this product to the owner once the repair is complete.
- 2. Replace this product with a direct replacement or with a similar product deemed by Solo Technology to perform substantially the same function as the original product.
- 3. Issue a refund of the original purchase price, less depreciation to be determined at the sole discretion of Solo Technology, based on the age and condition of the product at the time remedy is sought under this limited warranty.
