



Product Warranty

The length of Tripp Lite's product warranty varies depending upon the country where the product was purchased and the type of product you purchased. Products must be returned to Tripp Lite or an authorized Tripp Lite service center with transportation charges prepaid within 30 days of the product deficiency and must be accompanied by a brief description of the problem encountered and proof of date and place of purchase. Call Tripp Lite Customer Service before sending any equipment back for warranty service.

30-MONTH LIMITED WARRANTY
