This warranty gives you specific legal rights, and/or other rights, including a longer warranty period that may vary under local laws. Remedies

Mad Catz Global Limited’s entire liability and your exclusive remedy for any breach of warranty shall be, at Mad Catz Global Limited’s option,

(1) to repair or replace the hardware, or

Shipping and handling charges may apply except where prohibited by applicable law.
