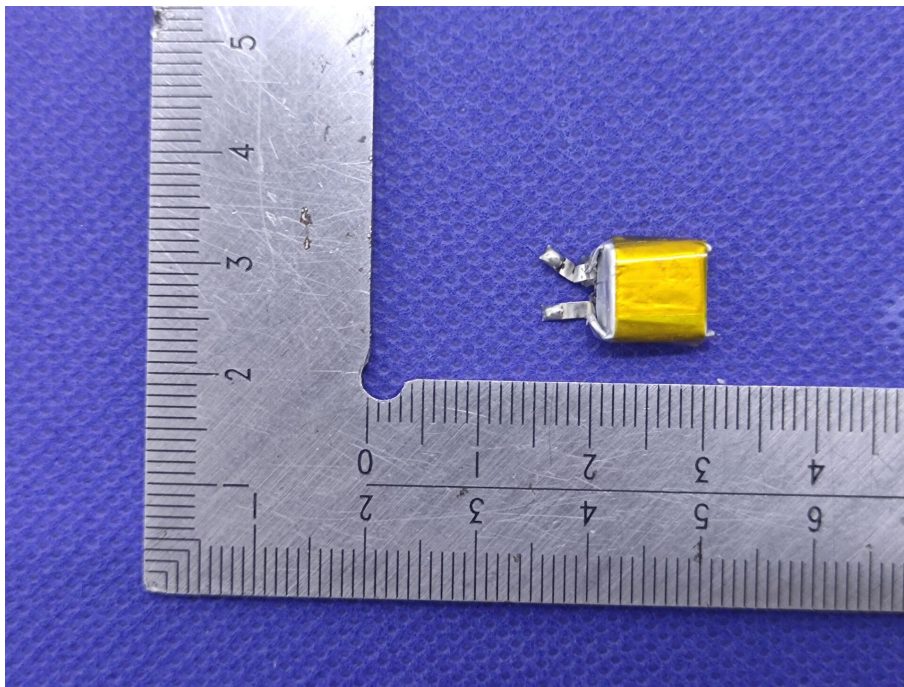
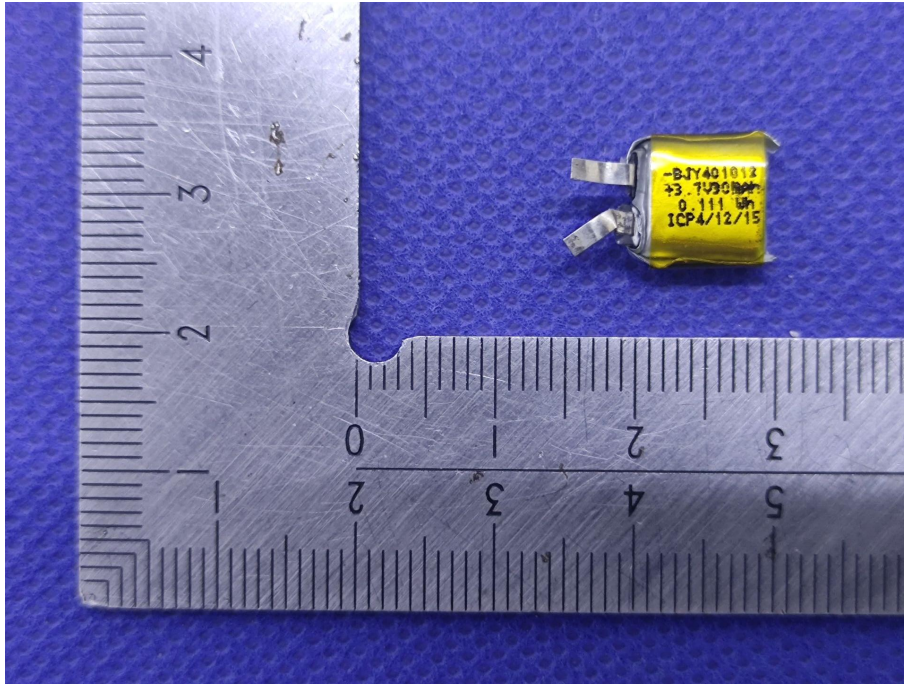

## 签发测试报告条款 Conditions of Issuance of Test Reports

1. 深圳市鑫宇环检测有限公司(以下简称[本公司])为提供符合下述条款的测试和报告, 而接受有关样品和货品。本公司基于下述条款提供服务, 下述条款为本公司与申请服务的个人, 企业或公司(以下简称[客户])的协议。All samples and goods are accepted by the Attestation of Global Compliance (Shenzhen) Co., Ltd (the “Company”) solely for testing and reporting in accordance with the following terms and conditions. The company provides its services on the basis that such terms and conditions constitute express agreement between the company and any person, firm or company requesting its services (the “Clients”).
